#### **CHAPTER I**

#### INTRODUCTION

#### A. Background of The Problems

However, psychology can be used to support in analyzing a literary work (Wellek dan Werren, in Fananie, 2000: 90)

Trauma describe a range of emotionally unpleasant events, we feel it is important to first identify our use of the term. The Diagnostic and Statistical Manual (1994) of the American Psyciatric Assosiation, which characterizes trauma as an episode that creates overwhelming fear that oneself or a loved one is about suffers severe injury or death and is accompanied by the belief that little can be done to control, minimize or escape the injury. Trauma that can possibly happen because of losing something, such us death of family, couple, or people who have good relation. Although trauma can be caused by psychological action, the effect is more arisen to someone's psychology. However the Psychological

trauma exists. This is the real effect that will be faced by someone who has traumatic experience. (Bowers, G. H & Heidi Sivers. 1998)

An anxiety disorder occurs when anxiety starts to severely impact on a person's life. Rather than feeling anxious in response to actual danger, someone with an anxiety disorder will experience the same symptoms in situations they perceive as dangerous (e.g. meeting new people or taking public transportation). Anxiety disorders aren't caused by a single factor, but rather by a combination of things. A family history of anxiety, a person's physical health, personality traits and stressful life experiences can all be contributing factors. Anxiety disorders are likely to develop over time and are usually sustained by unhelpful thinking patterns. (Ester A. Leutenberg and John J. Liptak. 2011)

In this term paper, the writer took one of Claire Allan's novel Her Name Was Rose. And I will analyze the Traumatic and Anxiety in this novel. The story focuses on Emily, whose life is a mess. Emily, a messed up young woman who finds herself the witness of a shocking hit and run accident that kills a young mother, and after that accident Emily suffering from her traumatic experience and anxiety.

Her Name Was Rose captures the characters Emily who is suffering from her traumatic and anxiety, also finds herself way out of her comfort zone, yet holding on tight with a fear of the unknown ahead.

Based on the illustration above, the writer took the analysis of trauma in Claire Allan's novel as the title of this thesis. Therefore, this study will present deeper analysis about traumatic experiences and anxiety in this novel.
