#### **CHAPTER I**

#### INTRODUCTION

### 1.1 Internship Background

In "International World Order", interactions that occurs between various countries nowadays is very commonplace, coupled with a rapid development of globalization and technology make the interactions between these countries somehow transparent and easy to observe. # 1.4 Procedures of Internship

In order to fulfill the prescribed procedures when wanting to undergo an Internship Program, it should be noted that the rules and regulations which has been applied at Darma Persada University including an Internship Program, that it's only available if students have enter the 6th semester or even semester of the learning year and it's also available if students have completed a minimum amount of Semester Credit System namely 100 SCS.

Regarding student's selection of the place to apply an Internship, students could first find informations about the work systems within the Agency that they curious about or they can also do a consultation about this topic with their Lecturers or an Alumni who were experienced on dealing directly with the Agency's work system. That way they already have a picture on their mind about the work environment and the scope of tasks within an agency they will meet later.

Afterward, students can submit a letter regarding "Application for Internship Program" which has been approved by University as it was one of the requirements that must be fulfilled and addressed to the agency they interested in, and that letter specified the time, date and day to begin the Internship Program.

### 1.5 Scope and Scheduled Times

During this activity, as i said previously, i had the opportunity to directly choose "Center for Policy Analysis and Development for Asia-Pacific and Africa Region (P3K2 Aspasaf)" at the Policy Analysis and Development Agency (BPPK), as a place to learn more about the real work environment.

Ministry of Foreign Affairs of Republic of Indonesia is located at Jln. Taman Pejambon No. 6, Central Jakarta. My division is located on the 3rd Floor of Gedung "Roeslan Abdul Ghani".
