CHAPTER 1

INTRODUCTION

A. Background of the Research

The quote is adopted from Second Treatise of Government that Locke wrote. He believed that the human rights are natural rights that we have since we were born. It is governed by the law of nature where people in the state of nature conditionally transfer some of their rights to the government in order to better ensure the stable, comfortable enjoyment of their lives, liberty, and property. This requires each individual to relinquish all of his or her right to punish those who transgress the law of nature and that portion of his or her right "to do whatsoever he thinks fit

for the preservation of himself, and others within the permission of the law of nature that is required for the preservation of civil society. The government legally punish the violators based on what she has done but still cannotremove the natural rights that she has. Then what about the death penalty? Capital punishment or the death penalty is a legal process whereby a person is put to death by the state as a punishment for a crime. In June 13rd, 2017, Karin published her new work, a very fine psychological novel, "The Good Daughter." Rusty Quinn, a well-known lawyer in Pikeville, not because the standard of what people call noble jobs that he has done, but the controversies that he makes by defending murderers, rapists, robbers, and other guilty people.

His oldest daughter was shot on the head, his youngest daughter was rapped, and he also lost his lovely wife on the same day. Those incidents do not make him want the charged to be executed. A murderer takes someone's life. A rapist takes someone's future. A robber takes someone's property, Rusty is there to defend them. The philosophical aspects in the novel attracts me to conduct a research about the philosophical thoughts and gain deeper knowledge of the reflection of natural rights.

B. Identification of the Problem

Based on the background above, the problem of the research is to identify the reflection of philosophical concept of natural rights trough Rusty Quinn character in Novel *The Good Daughter* by Karin Slaughter.

C. Limitation of the Problem

Based on the identification of the problem above and to make the research is more specific, the problems of this research are whether death execution necessary for murderers and the reflection of philosophical concept of natural rights by John Locke through Rusty Quinn character in The *Good Daughter* novel by Karin Slaughter.

D. Formulation of the Problem

According to the limitation of problem above, the problems in this research are formulated to prove the reflection of philosophical concept of human rights through the character Rusty Quinn by defending his clients from death sentence. Therefore, the problems in this research are formulated as follows:

E. Objective of the Research

Based on the formulation of the problem above, the objective of this research is to prove the assumption of the reflection of philosophical concept of natural rights by John Locke through Rusty Quinn character in this novel. The steps which are supposed to be done in this research are as follows:

- 2. To analyze the novel by using intrinsic concepts such as, setting and plot; and extrinsic concept by using human rights by John Locke.
