He is the best known for his screenplay for the 2000 film Billy Elliot. As a script writer he has won awards that is 2001 Best New Comedy, 2008 Best Play, 2008 Outstanding Book of a Musical, 2009 Best Original Score (Music and/or Lyrics) Written for the Theatre, 2009 Best Book of a Musical, 2009 Best New Play, 2009 Best Musical and 2009 Best Book of a Musical.

The things that motivate Lee Hall to make the Book script and the passion to make the film because he sees Abdul's character as a representation of India in reality have a things to convey to the audience and readers that as an Indian in the British region at that time it is not easy, and there is much resistance and efforts to survive in palace. Lee Hall gets in touch with Shrabani, and she realizes that it is an amazing story apart from of the most powerful woman in the world, in outline Victoria is an English queen in the 19th century, she could have a very close relationship with ordinary people. Victoria, in fact, is a white person who is considered to have power that is always dominant or a minority, but she can have good relations with a minority people, as in the figure of Abdul as an Indian, where he is a commoner who has

jobless in England, but Victoria make him as a servant, then has promoted again as a spiritual adviser, and it is Victoria have done that surprise all British circles at that time. Hall makes a script through the humour and that is in sort of a tradition of British Film making that they do.

Regarding from Shrabani Basu, she is a writer from Victoria and Abdul: The True Story of The Queen's Closest Confidant Novel whose was published in 2010. After that, they make it into a film directed by Stephen Frears on September 15, 2017 with the title "Victoria and Abdul".

As a journalist, Shrabani Basu always observes in detail by traveling to find out her main history especially in the histories of India and Britain, also with the people that she will involve in the content of the story to make the work become something that has clear contents. The beginning why Shrabani Basu write a novel Victoria and Abdul because the first time Shrabani Basu hear of Abdul Karim, she is carrying put research for a book about the history of curry in the late 1990s. A few years later while on holiday with her family, she comes across a painting of Karim in Osborne House, a former private home of Queen Victoria and Prince Albert on the U.K'S Isle of Wight.

In this study, this film shows about the conflict between two countries, India and England in the war. This film also shows a relationship between the characters namely Victoria as queen, Abdul as servant and Bertie as children of Queen Victoria where they have their own personality or patterns such as stimulus, response and effects through their character. The interesting things here are the friendship between Victoria as a Queen of England and Abdul as an Indian servant, their first meeting happen when Abdul should give a Mohar to Victoria, and the British don't let Abdul and Mohammed make eye contact with Victoria while gives Mahar, but Abdul break the rules and make people in the palace get angry. Because of the eye contact with Abdul, Victoria gets curious and gives an order to people in the palace that Abdul should stay in India.

At that time India is imprisoned by the British, Abdul and Mohammed go to England as representatives of India to give a gift to the Queen of England, while Victoria is flattering to Abdul because she has an interest in terms of Abdul's inner beauty. Abdul and Mohammed become a servant in the palace. However, they are not staying in the place, but in outside of palace. Their position is lower than palace guard and servant, because Mohammed and Abdul are an Indian and have coloured skin. So that all of British who is in the palace give a bad view toward Abdul. It doesn't make Abdul feel down, but be more friendly and makes Victoria impressed to him. The first approached Abdul to Victoria is when Abdul shows the beautiful side of India, tells Victoria about Indian culture, and teaches Victoria how to write in India Language that is Urdu. Because of the existents of Abdul in the palace, it has changed Victoria as a Queen. She changes the rules and that makes Bertie and all the palace residents dislike it and feel anxious. The British grew furious at Abdul who is more confident in the palace. the court try to get rid of Abdul in a variety of basic ways such as Bertie advises Victoria, then carry out the doctrine assisted by Dr Reid and Ponsonby to reveal Abdul's background and weaknesses to Victoria, and an impudent manner when Miss Phipps threatens Victoria, if Victoria still cares about Abdul, they will resign from the palace. All of the things they do, it doesn't make Victoria feel scared and threatened, but instead, Victoria increasingly protect Abdul and use her authority to order them all to be courteous to Abdul. When Victoria died of a heart ailment, all those who lived in the palace are devastate by the incident, but it is undeniable that they are happy, because their plan to kick Abdul from the palace will come true. They got rid of Abdul quickly by burning all Abdul's belongings as a form of coercion to get out of the palace immediately. Eventually they returned to India, Abdul is not give up his friendship with Victoria that they have.

1.2 Identification of the Problem

Based on the background above, I identify that Abdul just wants to show the beautiful side of Indian to Victoria, and Victoria itself wants equality between human beings regardless of race and culture. While in the British side is looking-down to Abdul and

trying to expel Abdul in various ways. I assume the theme in this movie is the reflection of behaviourism personality creates aggression.

Based on the identification of the problem above, I limit research on my theme by analyzing the characterization and use the concept of a literary character approach to indirect methods (showing) with dramatic method followed by plot and background.
