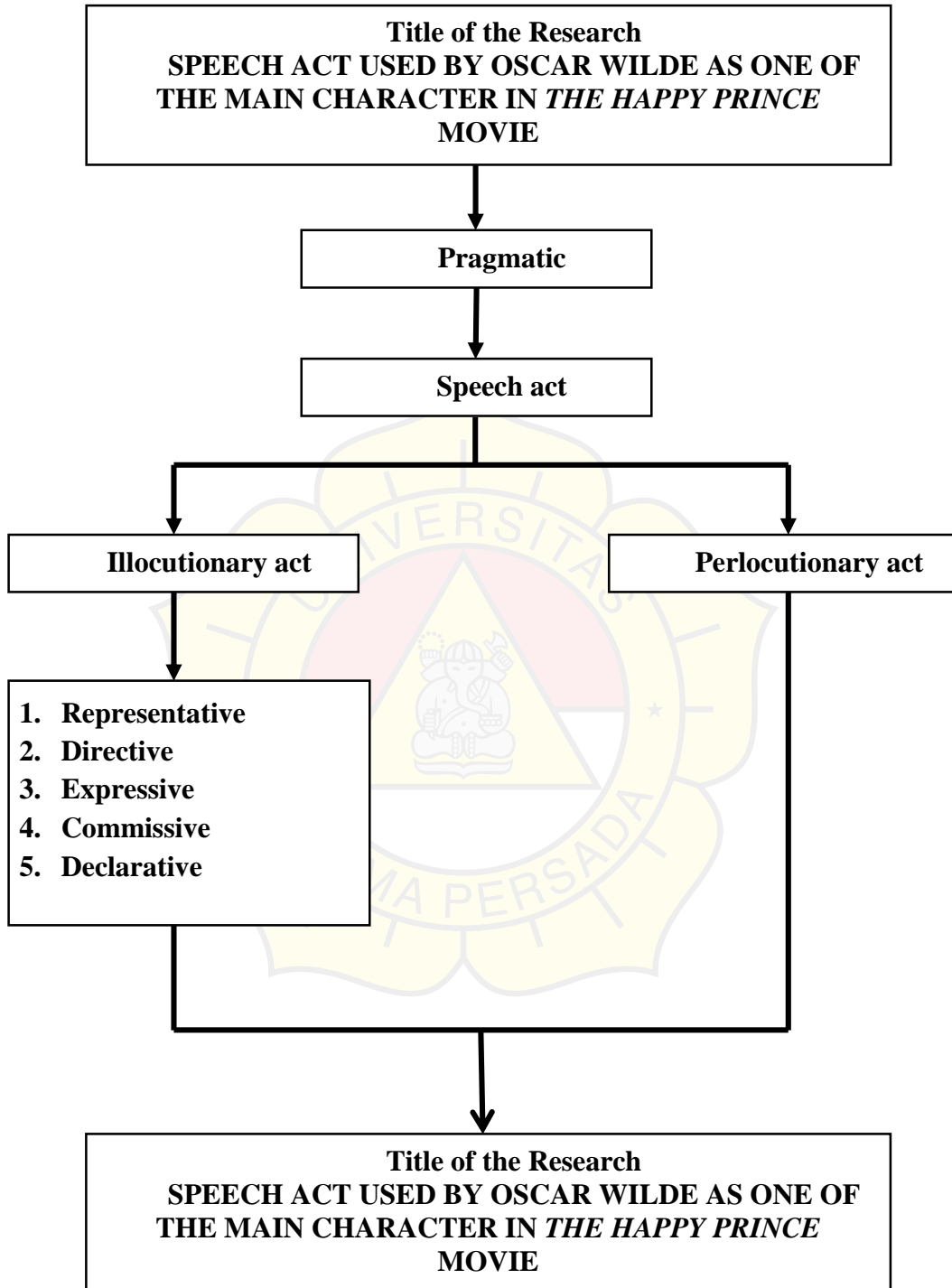

BACKGROUND Speech acts is utterance of speech that constitutes some sort of act. However, understanding utterance is not an easy thing. At the moment understanding the utterances of a person often makes mistakes so it is evident that understanding of utterance is a difficult problem.

METHODS Qualitative method is used to analyze the types of illocutionary act and perlocutionary act of illocutionary act in this movie. The use of it is more appropriate for the writer because the source of the data is only from subtitle and movie itself by collecting data and analyze it.
