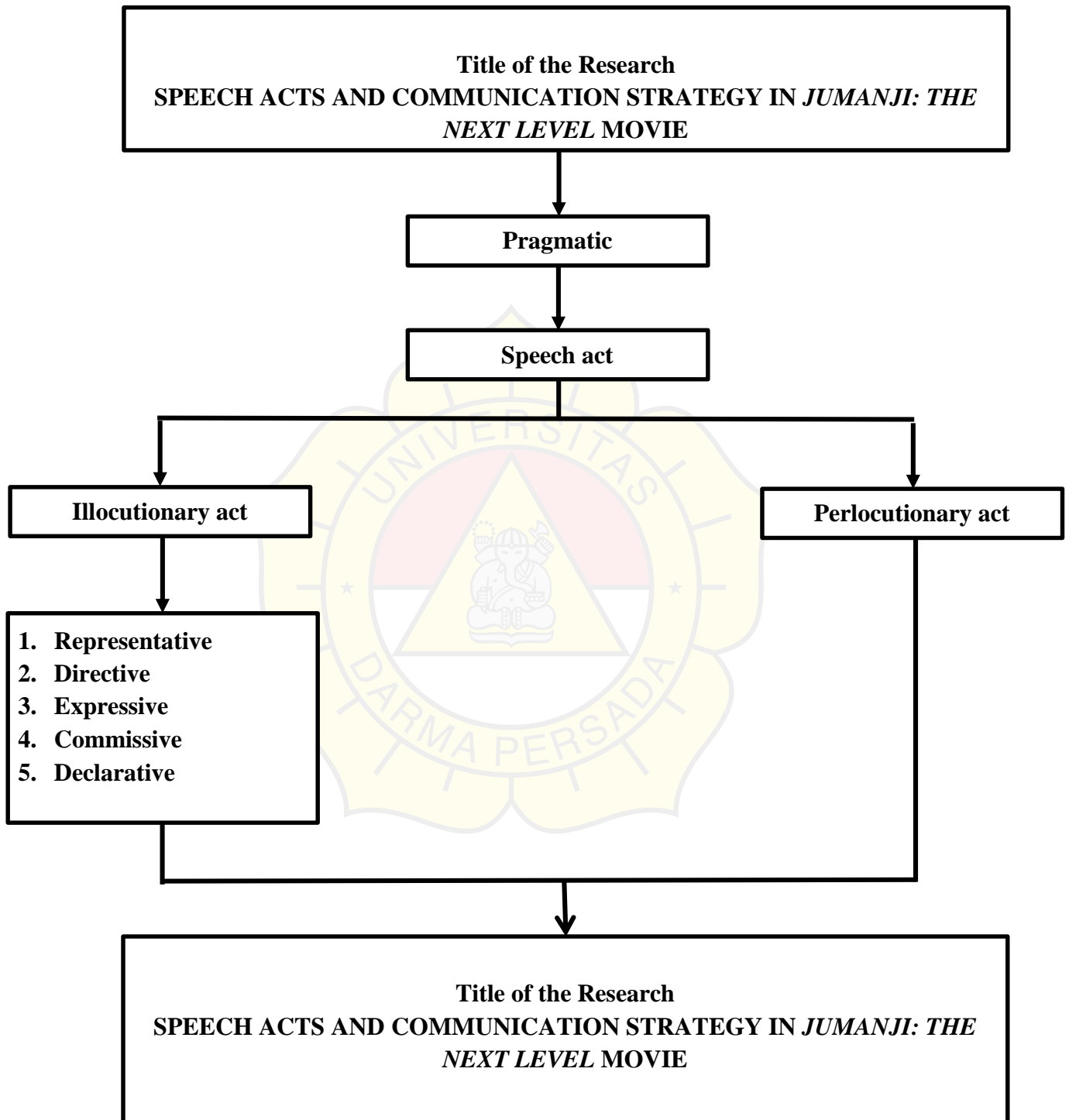

BACKGROUND Speech acts is utterance of speech that constitutes some sort of act. However, understanding utterance is not an easy thing. At the moment understanding the utterances of a person often makes mistakes so it is evident that understanding of utterance is a difficult problem.

METHODS Qualitative method is used to analyze the types of illocutionary act and perlocutionary act of illocutionary act in this movie. The use of it is more appropriate for the writer because the source of the data is only from this movie by collecting data and analyze it.

BENEFIT This research is expected to help those who have the same analysis or need the same references about speech act, especially in the movie.

RESEARCH FINDING the writer found at least 56 utterances contain illocutionary act used by the main character. The utterances are 21 of representatives, 25 of directives, 6 of commissives, 3 of expressive and 1 of declaratives. Then the analysis of perlocutionary act/effect on addressee after utterances is stated of its illocutionary act found 42 utterances.

CONCLUSION The illocutionary act found more than one illocutionary act. Not of all illocutionary act have perlocutionary effect.
