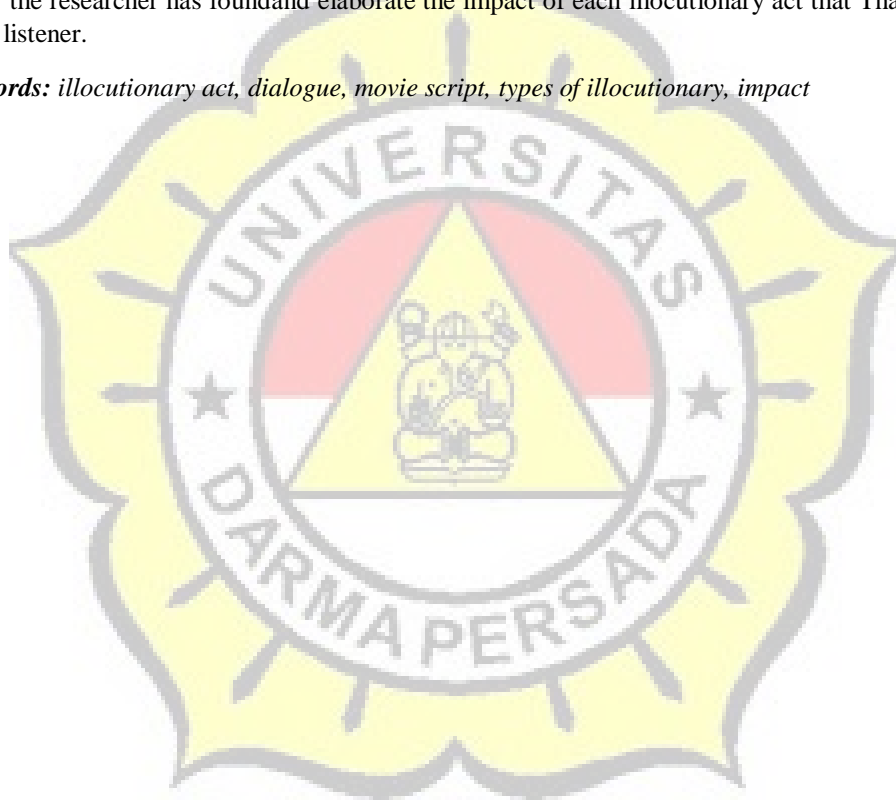

ABSTRACT

This study aims: to explain Thanos' illocutionary acts found in the movie script "Avengers: Infinity War", to describe the illocutionary functions used by Thanos in the movie script "Avengers: Infinity War", and explain the impact of illocutionary acts Thanos to his listeners. This study uses a qualitative descriptive method. The data is obtained from the dialogue of the main character in the Avengers Infinity War moviescript. The results of this study indicate that: first, there are five types of dialogue illocutionary acts of the main character in the Avengers Infinity War film script such as assertive (17), directive (11), commissive(9), declaration (1), and expressive (6). Second, the researcher has found six reasons why the types of illocutionary acts are manifested in the Avengers Infinity War film script. Third, the researcher has found and elaborate the impact of each illocutionary act that Thanos uttered to the listener.

ABSTRAK

Penelitian ini bertujuan: untuk menjelaskan tindak ilokusi Thanos yang terdapat dalam naskah film “Avengers: Infinity War”, mendeskripsikan fungsi ilokusi yang digunakan Thanos dalam naskah film “Avengers: Infinity War”, dan menjelaskan dampak ilokusi bertindak Thanos kepada pendengarnya. Penelitian ini menggunakan metode deskriptif kualitatif. Data tersebut diperoleh dari dialog tokoh utama dalam naskah film Avengers Infinity War. Hasil penelitian ini menunjukkan bahwa: pertama, terdapat lima jenis tindak ilokusi dialog tokoh utama dalam naskah film Avengers Infinity War yaitu asertif (17), direktif (11), komisif (9), deklarasi (1), dan ekspresif (6). Kedua, peneliti menemukan enam alasan mengapa jenis tindak ilokusi dimanifestasikan dalam naskah film Avengers Infinity War. Ketiga, peneliti telah menemukan dan mengelaborasi dampak dari setiap tindak ilokusi yang diucapkan Thanos kepada pendengarnya.
