## **CHAPTER 5 CONCLUSION**

After analyzing Harriet movie script, through the intrinsic approach, which consists of characterization by showing and telling methods, plot, and setting, elaborate with analysis through the extrinsic approach by using a racial discrimination concept. By using the showing and telling method can reveal the characters of Harriet Tubman, Gideon Brodess, and William Still. From the plot, we can see the relationship between the characters and the conflicts in the movie script. And by the settings, we can find out more details from the characters to the plot.

It can be concluded that Harriet and other black people in the Harriet Script by Gregory Allen Howard are express the racial discrimination done by white people. They become slaves to their masters and always get tortured. Slaves were made into property that could be trade by their masters. Because of this problem makes one of the black slaves name Minty (Harriet) runs away from her master (Brodess) because she will be on sale. This makes the beginning where Harriet become<mark>s Moses to help the other slaves escape</mark> and seek their own freedom. She gets an excess from God and also she is a religious person, she gets a vision from God to save other slaves who have not got their freedom. After a long search, finally, Gideon meets Harriet and asks her to come back. Harriet refuses and take an action to against Gideon by shooting Gideon's hand until it bled. The extrinsic approach in my research uses the theory of racial discrimination and also the theory to against discrimination. In this analysis, shows the existence of racial discrimination done by whites towards black people.
