# **CHAPTER I**

## **INTRODUCTION**

#### **1.1 Background of the Problem**

Psychological fiction is a term used to describe a novel that struggles with the spiritual, emotional and mental aspects of the characters by studying more of the character than studying the plot or events (Minderop, 2010, p.53). In this research, I will dissect the motifs found in Kate Ouinn's novel entitled The Huntress.

Kate Quinn is the New York Times and USA Today bestselling author of historical fiction. She has written five novels in the *Empress of Rome Saga*, and two books in the *Italian Renaissance*, before turning to the 20th century with *The Alice Network*, *The Huntress*, and her latest novel *The Rose Code*. *The Huntress* was published in 2019.

The plot in this novel starts from 1937 until the end of 1950. The novel weaves together the stories of three different characters: Jordan McBride as an American

photographer whose her father falls in love with a mysterious woman. Ian Graham who work as a correspondent committed to exposing war criminal. Nina Markova as a Russian pilot. This novel is about the challenges riddling the hunters and hunted in Russia, England, and United States.

The focus of this research on the character of Ian Graham. He has a brother named Sebastian. Ian works as a correspondent who also hunts war criminals, but he fails to uncover the crime that killed his brother. Sebastian was killed by a Nazi during World War II. This makes Ian want to take revenge on the murderer of his brother named Lorelei Vogt. This is where the structure of Ian's personality, as a vindictive, a pessmist and as a wise man will be seen in reflecting on his revenge and then influencing the ways and actions he chooses to take revenge. Ian Graham wants to seek justice by taking revenge on his brother's murderer. In explaining the motive for revenge, I will use the theory of personality structure in analyzing Ian's personality.

#### **1.2 Identification of the Problem**

#### **1.3 Limitation of the Problem**

# 1.6 Methods of the Research

1. The Unit of Analysis Data

The unit analyzed in this research is The Huntress by Kate Quinn as the main source and supported by several references, such as books and articles from the internet related to the study as a second source, associated with theory and concept.

2. Research Instrument

In collecting data, I uses himself as the instrument to analyze accurately the phenomena relating to the research question reveals in this research.

3. Technique of Analysis Data

The technique which is used in analyzing the data is descriptive analysis. The step of descriptive analysis are: (1) Reading the novel repeatedly, (2) Identifying the character that will be analyzed, (3) Taking notes of important things both from a primary and secondary data source, (4) Reading some related books and articles from the internet to find out the theory, data and information needed.
