CHAPTER I

INTRODUCTION

1.1 Background of the Problem

In this generation, issues related to racism and discrimination are very sensitive issues to discuss. Because these acts are carried out not only on adults but also with minors, an example of such acts is bullying. Bullying perpetrators have a high sense of superiority towards the victim, so they feel appropriate to do things that include bullying the victim. Usually, these actions are due to differences in race, ethnicity, religion, skin color, social class, gender, political orientation, physical condition, or other characteristics that an act of discrimination. There are many types of discrimination in this world, namely age discrimination, religious discrimination, health discrimination, gender discrimination, and racial discrimination. It will be noticed that racial discrimination is against human rights because it creates tremendous suffering for certain nations and races. Racial discrimination happens once someone is treated less favorably, or not given constant opportunities, as others in an exceedingly similar scenario, due to their race, the country wherever they were born, their ethnic origin, or their color.

However, thanks to Tony Lip, the tour became easier and they became very close, but in the film, it is very strongly depicted how white people at that time committed acts of racism not only with black people but with Italians.

This research will reveal how racial discrimination reflects on the script of the Green Book movie. Racial discrimination is one of the worst problems that still arise among people in the world until now. It can be defined as the mistreatment of people on the basis of race, color, and religion. Racial discrimination is also the belief that race accounts for differences in human character and that a particular race is superior to others.
