After analyzing this novel I can conclude that the intrinsic approach can be used to analyze this novel. I have applied showing and telling methods to know how the characterizations of some characters. The characters whom I analyze are Alicia Berenson and Theo Faber. Then by using the concept of setting, especially the five function of setting, I can know the setting of this novel. Also, by using the concept of plot, I can analyze the plot of this novel from exposition until resolution. After analyzing the characters using the telling method and showing method. I can conclude that the main character in the novel, Alicia Berenson has several characters, such as anxious person, traumatic, self-harm and lovable. Beside Alicia, I also analyze the other characters used to strengthen the main character and is important in the characterization of the main character including Theo Faber as someone who is a smoker, traumatic and hypocrisy person.

"The Silent Patient" novel plot consist of of five parts, namely exposition, complications, crisis, falling action, and resolution.
