

# CHAPTER 1

## INTRODUCTION

### 1.1. Background of the problem

Speech is a form of communicative ability which has the aim of conveying a message to the general public (Sidabutar, 2014, as cited in Bulan and Kasman, 2018). In giving speeches, especially speeches delivered by political figures, their political interests are very conditional, be it personal, group or community to support their true desire. Making a speech means to produce language or discourse which can then be interpreted by the listeners. In this case, speech must be analyzed using Critical Discourse Analysis (CDA). Critical Discourse Analysis (CDA) is a field that is concerned with studying and analyzing written and spoken texts to reveal the discursive sources of power, dominance, inequality and bias. It examines how these discursive sources are maintained and reproduced within specific social, political and historical contexts (Van Dijk, 1998, as cited in, Damanik, 2018). We can also find the ideology that the speaker wants to share to the audience.

In this research, I want to analyse about Kamala Harris speech at Democratic National Convention 2020. McNamee (2021) states that Kamala Devi Harris or Kamala Harris is the first woman vice president candidates of America. She was born in October 20, 1964 at Oakland, California. Kamala Harris is a Jamaican and Indian descent. Her parents were activists, instilling Kamala Harris with a strong sense of justice. They brought her to civil rights demonstrations and introduced role models, ranging from Supreme Court Justice Thurgood Marshall to civil rights leader Constance Baker Motley, whose work motivated her to become a prosecutor. She had previously as attorney general of California (2011–2017) and served in the U.S. Senate (2017–2021). One of her achievements as attorney general is creating Open Justice, an online platform to make criminal justice data available to the public. She is the first woman of color on a major party's presidential ticket. She attended a historically black college (Howard University), is a member of a prominent black sorority (Alpha Kappa Alpha) and visited India often

while growing up. She often argues that her identity makes her uniquely suited to fight for people who have been traditionally ignored. When she was elected to be vice presidential candidate for the US, she became very excited to express his thoughts on building a better US than ever.

Kamala Harris got an opportunity to give a speech in Democratic National Convention in 2020. Democratic National Convention (DNC) is a convention held by the Democratic Party to select candidates for president and vice president. Kamala Harris who was elected as US vice presidential candidate gave a powerful speech and made all the Americans curious about her. Kamala was getting great public attention because of her new breakthrough.

Therefore, from the explanation above, Kamala Harris is the first black woman vice president candidates of America who got the opportunity to give a speech at Democratic National Convention 2020. She gives a special speech to share her thoughts and messages to all the Americans.
