

## CHAPTER V

### CONCLUSION

After analyzing *Fractured* movie script through the intrinsic approach which consists of characterization by using showing method, plot, and setting, I also analyze the movie script through extrinsic approach which is schizophrenia. I focus on psychological literature analysis. The result of the intrinsic approach analysis is elaborated with the extrinsic approach to prove that the theme of *Fractured* movie script is the schizophrenia of Ray Monroe as the main character. From the analysis of the previous chapter, I can conclude that Ray Monroe's schizophrenia symptoms are shown to support the theme.

The use of showing method for the characterizations of the characters in *Fractured* movie script is the part of the analysis. This can prove that Ray Monroe as the main character is an assistant manager, but he used to be an entrepreneur. Ray is someone who is huffy, alcoholic, family oriented, traumatized, and fearless. Some of these characterizations show his schizophrenia. The other characters are his wife and daughter. Joanne, his wife is patient and forgiveness. His daughter is Peri Monroe, she is talkative and clumsy. Their characterizations support Ray's schizophrenia.

The analysis of plot and setting also prove the theme of the movie script. The schizophrenia symptoms of Ray Monroe can be seen from the beginning of the movie script until the end. It starts when Ray and Peri fell into the construction hole at the gas station. When ray awake because Joanne shook his body, he pushed Joanne. He is traumatized and regretful because he had lost Abby before, and now he lost Joanne and Peri. He couldn't accept the reality and closed his eyes to make his own imaginary story like he wanted. At the hospital, the doctors said there was something wrong with Ray because he seemed confused. Especially, when they saw the footage of the security camera and when Ray answered the questions and told the story about what happened with a little stutter. Theory of mind is specifically impaired in schizophrenia and that many psychotic symptoms such as delusions, hallucinations, disorganized thought, disorganized behavior, and negative symptoms. Theory of mind in schizophrenia can explain the disorders and symptoms of schizophrenia.

To summarize, I can conclude that Ray Monroe's schizophrenia can be seen from the *Fractured* movie script characterizations, plot, and setting that show the symptoms of schizophrenia. The symptoms that can be seen are delusions, hallucinations, disorganized thought, and disorganized behavior. His schizophrenia was triggered by the accident that made him traumatized. Ray's mind became abnormal because of the experiences he had. Ray's confusion is also come up because when he fell, it hit his head.
