CHAPTER I INTRODUCTION

1.1 Background of the Problem

His work at Vassar College was the subject of his first film (filmed when he was 26), Kick and Screaming (1995). His second major film, The Squid and the Whale (2005). Baumbach directed three actors in an Oscar-nominated performance in the movie Marriage Story (2019), directed by Adam Driver, Scarlett Johansson and Laura Dern. He himself was not nominated for an Academy Award for Best Directing. Dahn won the performance at Marriage Story (2019).

The movie begins with a narration in which the couple Charlie Barber (Adam Driver) and Nicole Barber (Scarlett Johansson) are a harmonious, ideal and supportive couple. Meanwhile, Charlie is busy taking care of the drama being shown in his theatre. Although he is busy with work, he plays the role of a good father, husband, and son-in-law. Shortly thereafter, Nicole and Charlie officially divorced after the outcome of the trial was revealed. Nicole gets a 55/45 share of the child custody. This means she spends more time with her son. Both are divorced, but the love and affection between the two is still very clear. But that feeling is irreversible because it is hampered by a very strong ego.

In this case, I am interested in analyzing the film "Marriage Story" because I want to show where Nicole Barber's defence lies, using the film script and several methods as well as some quotes that will explain the theme to be analyzed.

1.2 Identification of the Problem

Based on the background of the problem above, Nicole is disappointed that Charlie slept with her co-worker, she decides to get a divorce because the mistake Charlie made was very fatal.
