CHAPTER I

INTRODUCTION

A. Background of the problem

Constance Briscoe (born 18 May 1957) is a former barrister, one of England's first black female recorders. Briscoe studied Law at Newcastle University, financing her studies by having several jobs at weekends and during the holidays, including working with the terminally ill in a hospital. She takes an MA at the University of Warwick. She was called to the bar in 1983. After she joined the chambers of Barbara a pupillage under Michael Mansfield, Calvert (the first woman to head a chambers). In 1996 become a recorder, a parttime judge - one of the first black women to sit as a judge in UK. Briscoe's legal practice focused on criminal law and fraud, principally defending. She also undertook tribunal work, public inquiries, inquests and acted as president of Mental Health Tribunals.

Briscoe is known for her books *Ugly* (2006) and *Beyond Ugly* (2008), in which she admits that she is abused as a child. She often speaks publicly about her experiences. Her mother, Carmen Briscoe, denies these claims and sue her daughter and her publishers Hodder & Stoughton for libel. Briscoe's mother stated she wished to have this civil decision reversed in the light of Briscoe's later criminal conviction for divert the course of justice. Police have confirm she also faces criminal investigation in relation to the evidence supporting the civil judgment in her favour.

Constance's family life is a major point of interest in the book and is really what the story revolves around. She comes from a broken family, with her dad leaving Constance, otherwise known as Clare with 5 other brothers and sisters and her mum. The Father is hardly around only to bring Christmas presents and food.

Clare is abused by her mother everyday, terrible physical abuse is inflicted on the growing body of Clare, benign cancer of the breasts is caused by constance punches and squeezing from her mother. Emotionally shut out and neglectes by her mother, abuse all the time by her mother and her new husband, frequently called UGLY and tells she is not welcome and unwanted. Home life is so bad Clare took herself off to social services and asked to be put into a home but is refused, feeling helpless and life is not living she is attempted suicide by swallowing a bottle of bleach. It is very sad to think that many children and teenagers are stuck in abusive families with no escape. The only thing that keep Constance sane and probably from death was school, Constance is very bright, she is told she has excellent potential but did not apply herself. Constance does not have enough time to do her homework as she is treated like a slave at home, cooking and cleaning. On a field trip to a court house then and there Constance is decided that she would become a Barrister. However Constance does not let this rattle her and went on determined to reach her goal, she is well on her way to achieving her goal.
