From the first statement problem, Jeremy passion's album "II" contains 68instances of figurative language. There are; 31 metaphors, 17 Metonymy, 9 synecdoches, 5 similes, dan 6 Personification.

In the second statement problem, the Researcher has analyzed the actual meaning of figurative language implied in the album such as; Metaphor, Metonymy, Synecdoche, Simile, and Personification contained in the Jeremy Passion's album entitled "II"

In the third statement problem, the researcher has conducted the most dominant type of figurative language found in Jeremy Passion's album II. A metaphor which makes up 46.6 percent of all cases in Jeremy Passion's album "II", is the most prevalent sort of figurative language. Metonymy ranks second with 25 percent, followed by synecdoche with 13.2 percent, Personification with 8.8 percent, and Simile with 7.4 percent.

According to the findings, Metaphor is the most prevalent sort of figurative language in Jeremy Passion's album "II". Because metaphor successfully helps a song sound more lovely and attractive it become the most prominest style to gain attention of listeners. Metaphor conjure up Rich Perception in the minds of listeners, makin it simpler for them to comprehend and remember the information that the musician intends to express with his songs.
