CHAPTER 1 INTRODUCTION

1.1.Background of the Problem

Wenar concludes in his book Developmental Psychopathology, emotional abuse is a type of abusive behaviour that is difficult to identify because it leaves no visible scar on the victim. However, many experts believe emotional abuse is just as dangerous as any other type because it harms the victim's self-esteem (Wenar, 1994: 395).

According to (Covert, 2020, p. 8) in her book, emotional abuse is to control the other person. As the abusers grow up, they come across situations in their lives that they cannot deal with healthily. So, they resort to controlling people or situations in order to deal with the discomfort they feel within themselves. Since people are unaware of the signs of emotional abuse, the abuser's behaviour and reactions go unchecked. They are reinforced over the years, causing them to believe this behaviour is the norm. Aggression and Gaslighting are part of emotional abuse. Aggression is when an abuser does not obtain what they want or believe. They cannot control, and they can become aggressive.

According to (Covert, 2021, p. 6), gaslighting is when someone tries to question, deny the truth of, ridicule, contradict, play games with, and simply confuse their victim. There are several reasons why some people employ this technique. Some use it to gain control over their victim; others use the victim to meet emotional, physical, or financial needs, or for vengeful purposes, out of jealousy, or just for the fun of it.

Ashley Audrain's novel, "The Push," revolves around Blythe Connor, married to Fox Connor, and their two children, Violet and Sam. The birth of their first child, Violet, initially brings joy, yet Blythe senses something amiss. However, her concerns are dismissed, with everyone seemingly believing Violet's version of events over Blythe's instincts. Blythe grapples with a haunting trauma stemming from her own abandonment by her mother, Cecilia. Cecilia, in turn, faced turmoil when Etta, Blythe's grandmother married her second husband, following the tragic death of Etta's first husband. Etta's own struggles led her to commit transgressions against Cecilia, echoing the cycle of tragedy and hardship within their family. These adversities from generations past have led Blythe to feel gaslighted and emotionally strained, impacting her relationship with her children, particularly Violet. Blythe

This research will focus on the reflection of emotional abuse on the main character in The Push (2021) novel.
