CHAPTER 1 INTRODUCTION

1.1 Background of the Research

Communication is an important thing we are doing right now and in life, we must be communicating with other people. Life does not work if we cannot communicate with each other because we all need to interact. Language must also be used for interaction by means of communication. We can use language to share ideas, emotions, and feelings with others in addition to purely interacting with them. Humans, the social environment, and language have no separation; all three of these elements are all important for social interaction and communication in daily life.

People must be able to communicate with each other effectively, give clear speech and must also provide sufficient and relevant information to the interlocutor. makes for efficient communication. People should also speak in a clear, honest, informative, and straightforward way, according to their respective portions. There are a number of rules that speakers must fulfill when communicating with others in order to effectively convey what they want to say, the rules are known as maxims.

Grice (as cited in Hossain, 2021:34) states that cooperation is deeply rooted in human communication and that people communicate effectively and appropriately with each other. Grice distinguishes between meaning and saying. He makes the case that speakers have the ability to convey implied meanings, and that listeners can deduce these meanings from their conversations with each other. He considers that individuals participate in certain ways and asserts that listeners usually presume that a speaker has provided enough pertinent information in their words. When it clearly violates from this presumption, we comprehend what it means. Consequently, a failure to comply does not imply a lack of communication.

The maxims that Grice states are as follow: quantity: provide as much information in your contribution as is necessary. Do not add more information than is necessary to your contribution; quality: do not say something you think is inaccurate. Do not make a claim for which you do not have sufficient proof; relation: be relevant to the topic; manner: avoiding ambiguity, avoiding confusion in your speech, keep it brief and well-organized. The existence of these rules does not guarantee that a conversation is always going to go well and smoothly, therefore, a conversation may be unsuccessful when the words being used are not relevant, honest, inappropriate or ambiguous., which in linguistics this phenomenon is included in Pragmatics.

According to Levinson (as cited in Pratiwi, 2021:6) pragmatics is a study of language from a functional point of view, that is defining that pragmatic is a language study that analyses linguistic structures that refer to non-linguistic problems. A language study that attempts to explain aspects of language structure by referring to non-linguistic pressures and reasons. Thus, pragmatics focuses the factors of language examined as non-linguistic and that is to say they are interactions between people.

Sometimes, people communicate not by directly saying what they mean, but they often use words that have implied meanings in communicating and it's called implicature. According to Grice (as cited in Al Ahda, 2022:1), the use of language in this situation has some hidden meanings or indirect ways to convey the words they want to talk. Because there are words that are not conveyed directly and the speaker likes to imply meanings in these words, a violation in communication occurs, making communication difficult.

This study aims to explain in detail the results of an analysis of violating and flouting said by the characters in the dialogue found in "Little Women" Movie Script. This aim is targeted because I want to analyze deeply about violating and flouting in "Little Women" movie script.

This movie script tells the life of four sisters in the March family, namely Meg, Jo, Amy, and Beth in the 1860s. These four siblings live in their modest home with their mother, while their father is serving as a war soldier. The four sisters are very close and familiar with each other. They often play together and help each other when one of them is having a hard time.

1.2 Identification of the Problem

Based on background of the problem above, I identify that characters in "Little Women" movie script are not cooperative when they are communicating with other characters so, the conversation does not go smoothly.

1.3 Limitation of the Problem

Based on identification of the problem above, I limit my research to analyze violating and flouting of maxims found in "Little Women." movie script. I use Grice's theory of cooperative principle as the base to analyze my research, I use Grice's theory because the theory is suitable for my research. I limit the utterances I found in the dialogue to a maximum 40 because I want to analyze the utterances with a smaller number in order to focus more on analyzing it.
