

CHAPTER 5

CONCLUSION

From the previous chapter that I have analyzed, I give a conclusion about violating and flouting that I found in “Little Women” movie script. The result data that I found after analyzing “Little Women” movie script can be seen below.

From the result above, I can conclude that in the “Little Women” movie script, the characters tend to violate maxim and they often violate maxim of relevance when having a conversation to each other.

Violating maxim of quality and relevance are mostly being used by the characters because they often to answer the question dishonestly and tend to answer the question with no relation to the question. They do not tell the truth and do not stay on the topic that is being discussed about.

The characters often deliberately flout the maxim by giving statements or answers that basically have implied meaning in the utterances they convey to each other. Flouting maxim of relevance is the dominant flouting maxim in "Little Women" movie script, which is the characters deliberately change the topic of conversation by delivering other answers that cannot be understood literally but the

listener must know what implied meaning is in the utterance delivered by the speaker and the speaker wants the hearer to know what is the implied meaning.

Therefore, from the data that I have analyzed in the previous chapter, the characters in the "Little Women" movie script often violate and flout the maxim of relevance because the utterances they convey often tend not to stay on topic, change the topic of conversation, answer a question not in accordance with what is asked and also provide answers with irrelevant. After concluding this research, I have some suggestions to the readers, the students and the next researcher about the topic discussed in this research.

For the readers, I suggest to at least find out a little bit about violating maxim, flouting maxim and implicature, because that is so interesting if you learn about it and that would be great if you want to learn more deeply about that topic. It is also will make you understand more and you can analyze the issues in the environment which is the utterance of someone who often violates or flouts maxim.

For the students, I suggest to learn more deeply about violating, flouting, implicature and the types of violating and flouting as well. If you have an intention to more deeply about it, it can make you easier if you want to use this approach for your research. You can also easily find out when people say something that you think it violates and flouts the maxim. You will understand more how to use the language and how to communicate with people around.

The last, for the next researcher who will analyze the movie script using the same topic, I suggest you to find movie script that you think it is contain a lot of violating and flouting so it can make you easier for taking the data. I suggest you to analyze more deeply about your research so it will help another one who wants to use the same topic.
