In this study, the writer uses script from (500) Days of Summer's film. The data which have been observed are classified into classification of speech acts by Searle and politeness strategies by Brown and Levinson. The study uses qualitative method which uses books as references. Classification of speech acts that is found are directives, representatives, expressives, commissives and declarations. Whereas politeness strategies that is found are bald on record strategy, positive politeness strategy, negative politeness strategy and off record strategy. The characters in this film tend to use politeness strategy through speech acts based on situational background. However, not all the utterances in (500) Days of Summer film apply politeness strategy.

#### **CHAPTER 1**

#### INTRODUCTION

# 1.1 Background of the Problem

In our daily life, language becomes important because as a tool, language can deliver the messages we send. It becomes harder when we communicate with language we do not understand. Therefore, language is created (based on agreement) to deliver the messages. Language brings us to the society of others. Through language, we can understand people's thought, desires, needs and so on. In other hands, language has a power. It proved with the expression of sadness, happiness, anger, embarrassment and so on. For instance, if someone we love says something such as "I love you," we must be happy. It is because those words come from the one we love. But if it is not, we will not feel the same way. In other words, language is so affecting how people treat us.

Language is part of communication. Communication is always two ways which means there are always two participants, speaker and hearer or addresser and addressee. When we communicate to each other, we always see the context or the situation in order to make good communication. Context is important because context is the background knowledge that speaker has to know before he or she utters something. Some of the time the speaker speaks something implicitly. The speaker wants the hearer to interpret what they mean. So, the hearer has to be able to interpret what the speaker means. Those things bring us to Pragmatics study. Pragmatics is the study that is more concerned with utterance meaning than the objective meaning of words. Pragmatics is an interesting study because we have to analyze what people say and find out what their intended meaning is. In Pragmatics, we can also learn about Speech acts and Politeness. Speech acts and Politeness are interrelated.

According to Yule (Pragmatics, 1996: 47) that speech acts are actions which are performed through utterances. In English, those have specific labels, such as

apology, complaint, compliment, invitation, promise, or request. In *How To Do Things With Words*, Austin offers Ordinary Language Philosophy concept. In this concept Austin states that human utterance in communication is often far from ideal, seeing from the structure or the meaning. He also assumes that human utterances are not just utterances. There is action in human language. That is what he calls as performative. For instance, when your boss says, "You are fired", you are automatically no longer his employee. But if those words are said by your partner, it does not change anything. This is what we call *Speech Act*.

There are two philosophers who proposed this speech acts theory, namely J. L. Austin and John Searle. J. L. Austin came first in publishing his book, *How to do things with words*, 1962. Inspired by Austin, Searle developed this theory. He published his book in 1969, *Speech acts: an essay in the philosophy of language*. He classified five types of speech acts. There are declarations, representatives, expressives, directives, and commissives. These functions are able to occur if there is speaker who is supported by situation. Some of the time we say something that is unconsciously is part of speech acts. For example, when the priest says, "I now pronounce you husband and wife." It is one of general functions of speech acts that we call declarations. We always hear that utterance in wedding ceremony. At that time, the priest changes someone's status through language (utterance). Another example is when judge says "I sentence you 10 years imprison." It changes someone's life too. This kind of functions relates to a special institutional role in a specific context.

As the writer mentioned above, context becomes important when communication occurs. Context, speech acts and politeness are interrelated while communication occurs. When we speak to someone we have to know with whom we speak. It is because as human we have face. According to Brown and Levinson, face is self-image which owns by people in the world. The meaning of face in this case relates to social and emotional meaning that other people should know. Politeness Strategy is proposed by Brown and Levinson in 1987. There are four strategies, Bald on record consist of two sub-strategies, Negative Politeness consists of fifteen sub-strategies, Positive politeness consists of ten sub-strategies and Off

record consists of fifteen sub-strategies. Politeness strategy is used to minimize face threatening acts that speaker does to the hearer.

In social interaction sometimes we say something in implicit way. We tend to try to make people discover what we actually mean. We do that sometimes in purpose in order to be more get communicated. There are some differences while communicating among friends, teachers or family. It is because there are some distances between them. As the writer mentions above, people has self-image that others have to respect. Therefore, we have to find appropriate words when we want to convey our intended meaning. We do not realize that some of the time we use politeness theory when we use speech acts. We tend to find appropriate words before we talk to our friends, teachers or family in order not to make them offended. It shows that we concerns about their face. We try to maintain their face by doing something that at least minimizes the threat to their face. In this case context also affect the choice of politeness strategy that will be conveys through speech acts.

The writer finds the relation among context, speech acts and politeness. Those are interrelated. Utterances are not only able be found in daily life but also able be found in dialogues of movie. In analyzing context, speech acts and politeness, the writer chooses data from the utterances of (500) Days of Summer movie. (500) Days of Summer is a 2009 American comedy drama film. It was written by Scott Neustadler and Michael H. Webber, directed by Marc Webb. In this movie, there are some utterances describing context, speech acts and politeness. From the utterances the writer is interested to analyze context, speech acts and politeness.

This film is presented in nonlinear narrative, as it jumps from various days within the 500-day span of Tom and Summer's relationship, indicated by an animation that includes the day's number. This film is quite interesting because of nonlinear narrative and unpredictable ending. Besides the story, the writer finds that the utterances the characters express contain speech acts and politeness that occur in the same time. So, the writer chooses this movie and the utterances as data for this research.

#### 1.2 Identification of the Problem

According to the background of the problem, the writer finds the major problem in (500) Days of Summer is the application of politeness strategies through speech acts among characters in their social interaction. Therefore, the writer assumes that the characters use different strategy depending on whom they speak with and also depending on the situation they are getting at. They do those things in order to be more get communicated. Also, when we do the speech act sometimes we also use politeness strategy in the same time.

#### 1.3 Limitation of the Problem

Based on the identification of the problem above, I limit the problem only the utterances which contains speech acts that were spoken by characters according to (500) Days of Summer movie and the application of politeness strategies to minimize FTAs.

#### 1.4 Statement of the Problem

According to limitation of the problem, the writer formulates the problem into three statements

- 1.4.1 What types of classification of speech act which are expressed by characters in (500) Days of Summer movie?
- 1.4.2 What politeness strategies which are applied by the character in (500) Days of Summer movie?

The writer uses those theories in conducting this research.

Based on framework of theory, the writer uses the qualitative research method that uses text document. Through this method the writer will analyze speech acts and the application of politeness theory in (500) Days of Summer film
