

CHAPTER 5

CONCLUSION

This chapter concludes the end of the research on Bruce Wayne's childhood traumatic events in "*The Batman*" (2022) movie script, which impacted his character. The explanation of his character and life experience that were portrayed in the movie's incident and script encouraged me to come to the conclusion of the research.

The first explanation focuses on an in-depth analysis of Bruce Wayne's character, who is a recognized and famous superhero identified by his dark personality, outstanding technical equipment, and excellent detective abilities. Bruce has thirteen characteristics that are shown in this movie, and I described them in the fourth chapter. There are reclusive, socially awkward, resolute, inexperienced, intimidating, strict, insomniac, apathetic, virtuous, compassionate, inventive, reckless, and irritability. Bruce Wayne's behaviors arise from an extremely devastating event that has significantly influenced his psychological state.

The second explanation focuses on the explanation of the impact of Bruce Wayne's childhood traumatic events. There are 4 features, visualized perceived memories, changed attitudes about people, life and the future, rage, and repetitive behaviors. In this research, these features were found in Bruce, where he often reimagines and feels regret for what happened. This can be seen in detail from the explanation in the previous chapter. From this analysis, it is also known that the murder of Bruce Wayne's parents was a pivotal incident in his life that forever changed him. His parents were brutally killed in front of him at a campaign parade for the mayor of Gotham. Bruce, who was ten years old at that moment, saw his parents bleeding in despair and gasping their last breath while glanced at him, ensuring him an orphan in an instant and leaving him traumatized for life. The murder of Bruce's parents, Thomas and Martha, has been unsolved for decades, and no one knows why or who did it. Bruce was clueless about what actually happened, particularly his family's awful history. Bruce's goals as Batman transformed from

merely fulfilling his vengeance on criminals and helping oppressed people to becoming Batman who believed he could bring about change and believed that revenge wouldn't change anything as he learned about his family's past.

The third explanation is the reflection of Bruce's childhood trauma in the setting and plot. From the analysis, it is also known that there is a connection between childhood trauma and how the story progresses and is presented; this can be seen through the dialogue or actions that Bruce took in the previous chapter. He became a gloomy person and always imagined that occurrence. He seized on a persistent ambition to conquer his dread, safeguard himself and others, and establish an environment free of the despair he suffered. Bruce managed to cope with his emotions and was determined to unleash them to avenge the criminals by utilizing his pain productively. He also kept his emotions and perceptions to himself, even with his closest companions.

As a result, this research is projected to be useful for future researchers who are looking into different sorts of human psychology, particularly childhood trauma. It is intended to be utilized as a reference for future academics studying "*The Batman*" (2022) movie. Finally, this research may offer more information and can be used as a reference for future research analyzing human psychological using other things.
