Habitus produces and is produced by social life, meaning that habitus is a structure that structures society and also habitus is a planned structure. Habitus is formed after interacting with society in a certain time and space. Habitus is related to the arena, the arena is a space where individuals interact with each other and compete for symbolic power. Thus, Bourdieu defines habitus as a long-lasting & changing system of dispositions that functions as a generative basis for objectively structured & integrated practices. Even habits are related to capital; Capital must also exist in every arena so that the arena has meaning. An actor's legitimacy in social action is influenced by the capital they have. Bourdieu's capital is economic, cultural, social and symbolic. Economic capital is both material goods (which can have symbolic value) and intangible but culturally relevant qualities such as status, prestige, and power (referred to as symbolic capital). Culturally significant tastes and consumption patterns are referred to as cultural capital. The degree that gives rise to respect, reputation, holiness, or honor is called symbolic capital, and is based on the dialectic of knowledge. Relationships and networks of relationships serve as physical manifestations of social capital.

The story is set in the present time and moves forward. Crazy Rich Asian tells the story of a Chinese-American girl named Rachel Wu. He moved to America to work and became the youngest economics teacher at New York University. Rachel is dating Nick Young, a handsome young man from Singapore. Nick lives very simply and tries to save money: he uses Rachel's Netflix subscription, eats her desserts – and Rachel believes that Nick comes from a very poor family. However, Rachel doesn't think this is important, because money in this life is not the main thing.
