CHAPTER 5

CONCLUSION

Based on the previous chapter, which is chapter 4. In this chapter, I state my conclusion is that I have found there a lot types of deixis word or phrase in the utterances of "John Wick: Chapter 4" movie script. The person deixis in "John Wick: Chapter 4" movie script has 34 data classified into three categories. First, there are 17 data of first-person deixis, 14 data of second-person deixis, 13 data of third-person deixis used. So, there various person deixis such as "I, me, we, us, you, he, she, it, they, them" et cetera. There are many conversations between the characters to call each other, and refer to someone or others.

There are 11 data included in time deixis. These data are identified as time deixis because they contain types of deixis word or phrase refers to the time when the conversations between the characters happens in "John Wick: Chapter 4" movie script. So, there are various time deixis such as "now, last day, not today, then, yesterday" et cetera. There are 8 data included in place deixis. These data are identified as place deixis because they contain types of deixis word or phrase refers to the place where the conversation between the characters happens in "John Wick: Chapter 4" movie the conversation between the characters happens in "John Wick: Chapter 4" movie the conversation between the characters happens in "John Wick: Chapter 4" movie script. So, there various place deixis such as "here, this hotel, out there, outside" et cetera.

There are 7 data included in discourse deixis. These data identified as discourse deixis because they contain types of deixis word or phrase refers to the statement will be conveyed by the characters in the conversations "John Wick: Chapter 4" movie script, such as "that and this". There are 5 data include in social deixis. These data identified as social deixis because they contain types of deixis word or phrase refers to the social status between the speaker and the hearer in the conversations "John Wick: Chapter 4" movie script. So, there are various social deixis such as "your daughter, my father, Mr. Wick" et cetera.

In total number of types of deixis words or phrase in chapter 4, that I have used 75 data to analyze types of deixis found in "John Wick: Chapter 4" movie script. There are 44 data included in person deixis, 11 data included in time deixis, 8 data included in place deixis, 7 data included in discourse deixis, and 5 data included in social deixis. Therefore, the most dominant types of deixis that I found in "John Wick: Chapter 4" movie script is person deixis.

Finally, after finished this research. So, I can conclude that in "John Wick: Chapter 4" movie script, we can find the scriptwriter use many deixis to refers to many things. I hope in the future my term-paper can be used as references, or even analyzed further by others researcher. Also, I want encourage the readers, especially to the English Language Department students in Darma Persada University to learn more about the pragmatic specifically the study of deixis, because it can helps the collages students to understand interpret the meaning contained in the utterances.
