CHAPTER VI CONCLUSION

As the analyses have been conducted in the previous chapter, the writer starts the conclusion by answering the objectives of the research that is explained in the first chapter. It is to analyse the plot of Frank Lampard's personal life, to analyse the characters of Frank Lampard, and to analyse Frank Lampard as a multi-millionaire footballer using Maslow's hierarchy of needs.

In order to answer the objectives of the research, the writer uses two approaches to conduct the research that are intrinsic and extrinsic approaches. The intrinsic approach is applied to analyse the plot of Frank Lampard's personal life that is divided into five sections: Frank Lampard's profile as exposition, the struggle of Lampard Jr. as rising action, the beginning of a professional footballer as crisis and becoming a multi-millionaire footballer as falling action, and the multi-millionaire footballer as resolution. The other intrinsic approach that is used in the term paper is the character. It is applied by using characterisation through action and settings as a means of revealing character.

Furthermore, the writer applies the psychological concept as the extrinsic approach. The theory that the writer uses is the hierarchy of needs by Abraham Maslow. The theory is divided into five parts: physiological needs, safety needs, love and belonging needs, esteem needs, and self-actualisation needs. It is used in order to find out the result of the analysis of Frank Lampard to be a multi-millionaire footballer seen in Maslow's hierarchy of needs.

According to the analysis of Frank Lampard through intrinsic approach, there are three characters of Frank Lampard. They are hard-working, perseverance, and footballer. Those characters are the main characters of Frank Lampard that are discovered from the evidences taken from the book. Then, those evidences are analysed by applying characterisation through action and the setting as a means of revealing character from the intrinsic theory.

Subsequently, the writer also analysed the character of Frank Lampard related to the psychological concept as the extrinsic approach. Based on the analysis, the writer finds out that Maslow's hierarchy of needs are able to be applied on Frank Lampard's character. The research analyses every aspect of Maslow's hierarchy of needs upon the evidences taken from the book. Those aspects are the physiological needs, safety needs, love and belonging needs, esteem needs, and the self-actualisation needs as Lampard becomes a multi-millionaire footballer.

The benefit of the term paper is normally to present a scientific evidence of applying the intrinsic and extrinsic approach. In specific way, it is to prove the evidences of both the

characters as the intrinsic approach, and the hierarchy of needs as the extrinsic approach. The final result of the term paper is the reflection of Maslow's hierarchy of needs in Frank Lampard's character to be a multi-millionaire footballer. Nevertheless, although the result of this term paper is discovered, it remains available to be carried on. The writer proposes to whom interested of analysing the autobiography of Frank Lampard using psychological concept as extrinsic approach can conduct the analysis using motivation theory of DC McClelland (Asnawi, 2007:34).
