CHAPTER 1

INTRODUCTION

A. Background of the Problem.

In the Still of the Night is a romantic thriller novel by Charlotte Lamb which published in 1995. It tells about the projection and the aggression as self defense which has been done by Annie Lang, Johnny Tryone and Trudie Lang. According to *Introduction of Psychology* by Hirgard, the projection is unconsious mechanisms that against anxiety from failure or guilty. Then, aggression concept has denifition as a reaction of frustration because of anger, harted, and revenge. In real life, almost people experiences anxiety resulting from things uncomfortable and unacceptable. Then, this condition will strongly motivate us to do something not only to against anxiety by blaming other people but also became to aggressive to other people. Charlotte Lamb stresses on this topic in the novel entitled In the Still of the Night. Charlotte lamb is a famous romantic author. She was born in the East End of London in 1937. After graduated, she worked at the Bank of England and then at the BBC. She married with a journalist who spends most of his career on The Times. In their married, she has five children and now they live in a Victorian Gothic house on the Isle of man. She writes over a hundred books and twenty-five historical novels. In the Still of the Night is her first romantic thriller novel. This novel inspired from her favorite film. It tells about the love story of an actress in London who had many scandal in the past. I am interested in analyzing it because there are many problems which I can find through intrinstic approach and extrinstic approach. In the intrinstic approach, there are characterization, setting, and plot and in the extrinstic approach, there are two concepts personality psychology, especially about the projection and the aggression concepts from Sigmund Freud.

Charlotte lamb prefers to use a thrid person pronoun such as he, she, him and name in describing all figure. Annie Lang is the main figure and is an actress with the innocent face which had scandal in the past. There are two different men who had dominated Annie's past. Both of them vanished nearly eight years ago. Since that fateful night, ambition has driven Annie to the top. In the middle of her success, Johnny comes back. Furthermore, Annie known that she has made a relationship with Johnny and she has pregnant. Times goes by, she has decided to do the abortion because she is anxious when Johnny has vanished. She thinks Johnny never comes back. Beside that, Trudie Lang and Derek Fenn always forces her to do the abortion. She does not has a choice or strength to argue. After Johnny comes back to her, she tells all about her abortion to him and blames her mother and Derek who have forced her to do it before finally she meets him. Johnny is so angry planning to revenge them. He has tried to kill Annie's mother and Derek. Then, Derek is dead and her mother is almost dead. After this, Mike spreads a rumor about Annie and Derek to the press. Annie has been accused as a murderer. Annie tells again about it to Johnny and then he kills Mike too. At last, the press finds the body's Roger Keats who had died nearly eight years ago in Johnny's grandmother house, in Epping Forest. Finally, Annie knows that Johnny is a murderer. He has killed three persons in Annie's series, they are Roger Keats, Derek Fenn, and Mike Waterford. He blames them as people who has tried hurt Annie and all of them must be killed. Annie's mother is also became his target because she has separated them and has killed their baby. Johnny has killed his father too because Johnny's father hurts her mother when he was six years old. In the last story, Annie decides to kill Johnny to stop his crimes.2

B. Identification of the Problem.

Based on the background, I assume that the theme in this novel is reflection of the Projection and the Aggression as Self Defense in the Novel Entitled In the Still of the Night by Charlotte Lamb.

C. Limitation of the Problem.

D. Formulation of the Problem.

- 2. Can analyze of characterization, setting and plot be used to analyze the theme?

- 4. Can the theme of this novel be reinforced by using intrinstic and extrinstic appoarches?

F. Framework of the Theories

Based of the purpose of research, there are some framework of the theories to explain the intrinstic elements and the exstrinstic elements to support the analysis:

1. The Intrinstic Approaches

a. Characterization

Character is particular quality of actor that takes a place in a story and it is described by actions in plot. Characterization is character portrayal. Characterization methods in the study of literature is describing the character of the figures contained in a work of fiction. Disposition in a work of fiction can be explored through the quality of the mind, inner feelings, behaviors or habits, and can also through the appearance of the characters. In the present and determine the character (nature) of the characters the author used the method of characterization through omniscient point of view.³

1) Omniscient Point of View

In ominiscient point of view, the author is being outside the story reports each events from the figures exprerience or gives point of view by using third person pronoun such as he, she, etc. The author is able to express thoughts, feelings, views and motivations of the characters. This technique also called as an all knowing presence or third-person

omniscient because the author can freely move from one character to the other character to dramatize or summarize, to interpret, speculate, philosophize, moralize or judge. The omniscient point of view use to express what the author's point of view as the author's creation to describe all figures in the story.⁴

2) Setting

Setting is the term action that happen in the story can be related the time and the place. Setting can help the reader to visualize the action of the work, and thus adds credibility and an air of authenticity to the characters. Setting is consist of background for action, a revealing character, as antagonist, and as means of creating appropriate atmosfer.

- a) Setting as background for action to look when the background for action taken place in the story.
- b) Setting as means of revealing character to explain or describe the character in the story.
- c) Setting as antagonis to explain where the conflict happened in the story.
- d) Setting as means of creating appropriate atmosfer to create the reader mind of the event which happened in the story.⁵

3) Plot

The plot in fiction is refer to the deliberately arranged sequence of interelated events in the story. all fiction is based on conflict and this conflict is presented in a structured format called plot. The plot is consists a six elements, they are:⁶

a) Exsposition

The exposition is the beginning section in which the author has provided the necessary background information, sets the scene, establishes the situation, and dates the action. It also introduce the characters and the conflict, or the potential for conflict.⁷

b) Complication

The complication, which is sometimes refers to as the rising action. It is usually to build suspense all the way up the climactic finish. It introduces the characters and the underlying or inciting conflict. In disscuss, It will happens when the conflits has been developent by the author to create the story to more be interesting.⁸

c) Crisis

The crisis is also refer to as the climax is that moment at which the plot reaches its point of greatest emotional intensity. It is the turning point of the plot, directly precipitating its resolution. Sometimes the author also creates the foreshadowing before resolution.

d) Foreshadowing

Foreshadowing is a technique used by author to provide clues so the reader can predict what might occur later in the story. It can be placed by the author before complication or after climax to make the reader more be insteresting to read their novel. An author gives subtle clues about plot developments from each events which has explained in the novel to make the reader to think about what will be come later. It gives a reader an illustration that there are the paradox in the story and creates the reader's mind to more be understanding what the real happens in the story.¹⁰

e) Falling Action

Falling action is turning point of crisis has reached, the tension began subsides and the plot moves toward its appointed conclusion.¹¹

f) Resolution

Resolution is the final section. It also refers to as the conclusion. It records the out come of the conflict and establishes some new equilibrium or stability.¹²

4) Theme

The theme is primary ideas which base on the problems which it expressed by the author in the story. In this discuss, It will be appeared through characterization, setting, and plot which It will create a theme of the literature studies. It is also means as a moral lesson which it can be shown in each figures in the story.¹³

2. The Exstrinstic Approach by Pshycology Approach from Sigmued Frued

A. Literature Psychology

I use psychological approarch by using the projection and the aggression concepts. Psychology has assumed as the science that studies behavior and mental life processes. This concept learns about the phenomena of human problem in their contact with the outer world. The phenomena are such things as feeling, desires, desicision, motivation, personality, behavior, and interpersonal relationships. According to Freud, the psychology appoarch emphasize unconcious motives from human's behavior that impluses from their childhood. At this point, Freud believe that all of human's action can be arised from uncounciously. Basically, psychologists are interested to find why people act as they do. This study is also to understand a mental processes of human behaviour in a literature

1) Concept of the Projection

One unconscious mechanism that protects ourselves from recognition arising from failure or guilt called the projection. In the projection we protect ourselves from recognition of failure or guilt that comes from our selves with blaming someone else. The person who unaware of his own hostile impluses but sees them in other people and sees the others as a hater and a tyrant itsself is also included in the concept of the projection. According to Freud, the projection has assumed as a process which impulses own feelings, and sentiments that caused by others or circumstances outside in the world. The projection also means as changes mechanism from neurotic and moral anxiety to objective anxiety. It stresses the individual to hide or avoid their anxiety as self defense. This concept usually use to reduce own mind or feeling that arising by anxiety. ¹⁵

2) Concept of the Aggression

The aggression is angry reaction which express through attack an oject or hurt people. Someone who faces undesirable situation, normally will express his anger by attacking the unnatural way. In this case, the aggression is also means as self defense to protect ourselves or other people through against the danger that threaten our life. The aggression can arise from hostile behavior, such as harted, revenge,
