CHAPTER 5

CONCLUSION

This chapter contains conclusions from the overall analysis in the previous chapter. This research was conducted to find acts of racism through structural racial discrimination in the movie script Till (2022). The conclusion of this research can be formulated based on the research questions, namely: 1) What characteristics, plot, and setting are presented in the Till movie script? 2)How are racism, and Racial structural discrimination, revealed to the main character in the Till movie script? 3)How does the elaboration between intrinsic and extrinsic approach appear in the Till movie script?.

The characters in the Movie script are portrayed as emotional, particularly Mamie, the mother of Emmett. Mamie's character is emphasized through her relentless struggle to seek justice for her son's death. She is depicted as a figure of immense courage and determination, fighting against the Jim Crow laws that heavily discriminated against black people. Through dialogue and actions, the characterization demonstrates Mamie's strength and resilience.

The plot reflects the journey of the Movie Script, starting with the exposition, which introduces the main characters and highlights the bond between Mamie and Emmett. The rising action begins when Emmett visits a store to buy chewing gum and interacts with a white cashier, sparking the central conflict.
