#### CHAPTER I

#### **INTRODUCTION**

#### A. Background of the Research

Rosellen Brown was born in Philadelphia, Pennsylvania, to an Americanborn father and a Russian immigrant mother. She earned her BA from Barnard College and attended Brandeis University, where she met her future husband, Marvin Hoffman. The couple joined the Civil Rights movement, working at Tougaloo College near Jackson, Mississippi. While Hoffman continued a career in education, founding the North Kenwood/Oakland Charter School in Chicago, Brown turned to writing full-time. Her first book was the poetry collection Some Deaths in the Delta (1970); other collections include Cora Fry (1977) and Cora Fry's Pillow Book (1994). Brown is the author of the short story collection Street Games (1974) and many novels, including The Autobiography of My Mother (1976); Tender Mercies (1978); Civil Wars (1984); Before and After (1992), which was made into a film starring Meryl Streep and Liam Neeson; and Half a Heart (2000). *Tender Mercies* tells the story of married couple, Laura Shurrock Courser and Dan Courser who have live happily for twelve years. They have young children named Jonathan and Hallie Lavender. One day everything has changes, when Laura and Dan come to Los Angeles for a vacation. They feel bored with the atmosphere in Hyland. They meet Laura's cousin too. At that time, he wants to take Laura fishing in Palisades. Then, he borrows the boat of her cousin. He confidently tells Laura that he can ride it. Suddenly, he cannot control the boat. It causes an accident that makes Laura paralyzed from neck down. It makes her permanently unable to move or feel the arms and legs. It is associated with a variety of emotional reactions like despair and guilt, fear of losing control, disbelief and panic, helplessness and inadequacy, resentment & bargaining, loss of interests, loneliness and isolation.

After the accident she does many treatments that makes her suffered. She not only has to do rehabilitation in New York for a year but also has to do routine maintenance after she is coming out from the Rehabilitation Institute. She receives the pain mentally and physically. The accident scene always turns on her mind. She becomes traumatic. She feels no longer the same after the accident, she always feels frightened and hopeless. Traumatic effect not only makes her emotion unstable like sometimes angry, sad and calm but also makes Laura often has nightmares that always aggravates her trauma. It makes her have to consume sleeping pills. It makes her feel ease a little bit.

In other hand, the accident gives impact to Laura and Dan's marriage. The accident makes their relationship become wide apart. The love that used for Dan is full of intimacy, passion and commitment, now everything has changed. She hates the fact that she loses her beautiful and perfect life because of Dan. All the time, she always blames him and tries to ignore whatever he does or he tells. She tries to make him feel overwhelmed and depressed deal with her. She lets her husband be always pressured by Laura's parents and her sister, Carol. She almost thinks to end her relationship with Dan, but she remembers she has young children that still needs full of love and affection from their parents. In many months, she makes Dan feel punishment by his carelessness. However, Dan tries to stay very patient and he tries to return Laura's love.

## B. Identification of the Problem

Based on the background of the issue above, I identify that the problem of the research is a boat accident that caused by Dan and it makes Laura paralyzed. She becomes traumatic because of the accident. The traumatic effect of the painful tragedy drastically alters the course of their lives forever. The accident gives impact to their relationship, Laura's love is tested by this trial. I assume that the theme of this novel is traumatic experience and the power of love in Rosellen Brown's novel *Tender Mercies* 

#### C. Limitation of the Problem
